## INTERMITTENT SUPPORT FOR INTERNATIONAL CAUSES

### **COMPETITIVE FEES AND TIMING**

Myriad USA's fees are transparent and all-inclusive, and they vary depending on the type of gift. For example, with advised gifts and standard donor advised fund grants, we charge a fee on a sliding scale based on the grant amount (5%-.5%). Donations to Myriad USA's pre-vetted nonprofit partners have no fee to the donor.

Grant timing can vary based on nonprofit response time, but it usually takes two to four weeks from a grant recommendation for the grant distribution to be received by the grantee via wire transfer. Myriad USA is the new name for the King Baudouin Foundation United States (KBFUS). Building on the expertise of KBFUS and Give2Asia, we provide donors with a simple and efficient platform to support nonprofit initiatives overseas, anywhere around the world. Myriad USA is a member of the Myriad Alliance—an international network of likeminded partners who facilitate cross-border giving.
