## Intermittent Support for International Causes

## WAYS TO GIVE

As a U.S. public charity, Myriad USA receives many grants annually from community foundations with recommended causes and organizations abroad. Myriad USA also accepts a variety of assets, including non-cash assets, and we will work with you and your donors to facilitate tax-efficient giving.

## **COMPETITIVE FEES AND TIMING**

Myriad USA's fees are transparent and all-inclusive. With advised gifts and standard donor advised fund grants, the fee is on a sliding scale based on the grant amount (5%-.5%). Donations to Myriad USA's pre-vetted nonprofit partners have no fee to the donor. Grant timing can vary based on nonprofit response time, but after the gift is received, it usually takes three to five weeks from a grant recommendation for the grant to be received by the grantee.
